

	1.	The Christian who is not firmly grounded in Bible doctrine becomes highly <u>susceptible</u> to false teaching (Ephesians 4:11-16; Hebrews 13:9).		
	2.	Many false cults and sects, which in some way associate themselves with the Bible, prey upon untaught Christian converts who are gullible and hungry for religious teaching without always having the spiritual maturity to distinguish false teaching from biblical truths (Ephesians 4:14; Hebrews 5:12-14; Acts 17:11).		
	3.	The fundamental principle for the Christian is to be accurately taught in Bible doctrine so that he can readily <u>detect</u> doctrinal error (2 John 9).		
	4.	Doctrine drawn from the Word of God is the standard by which to detect religious heresy_mand_refute it (Titus 1:9).		
	5.	The root of the problem is that wrong doctrine inevitably results in wrong actions or disobedience.		
	6.	The gross sins which Paul lists in 1Timothy 1:9-10 are described as "contrary to sound teaching."		
	7.	Sound doctrine will always accord with Christ's teachings and it will conform to Godliness
